





DRAFT REA REPORT

Thank you for the opportunity to review the above noted reports with regard to our regulatory compliance role pursuant to the <u>Conservation Authorities Act</u> and mandate to help conserve and manage natural resources on a watershed basis. The Catfish Creek Conservation Authority (CCCA) is also responsible for evaluating the proposed works as to their impacts on fish habitat as per our Level II Agreement with the Department of Fisheries and Oceans (DFO), effective April 02, 2006.

Overall, the background information and natural heritage assessments contained in the documents are satisfactory for the identification of riverine hazards. In our opinion, the thirty (30) metre top-of- bank development setback for solar panel construction will be sufficient to protect the integrity of the slopes and associated vegetation.

Specific comments relative to the draft 'Construction Plan Report' include the following:

Page 12, Section 2.1.7 'Distribution Line'; this section should include a statement indicating that a permit is required by the CCCA, pursuant to the <u>Conservation Authorities Act</u>, for the water crossings. We support the installation of cable under the water courses utilizing the "directional drilling" method.

Page 13, Section 2.1.8 'Substation Construction'; The white pine plantation, which was established by the CCCA in conjunction with the previous owner, should be protected and managed on a long term basis to contribute to the biodiversity of the community. The CCCA can provide forest management advice and assistance, including the preparation of a forest management plan under the 'Managed Forest Tax Incentive Program' (MFTIP).

Page 18, Table 3; under 'Erosion and Sedimentation' a mitigation measure could include the installation of "conduit pipes" under the water crossings to facilitate future maintenance and minimize impacts to aquatic habitat.
